Endonuclease Activity (Nicking) - A 50 µl reaction in NEBuffer 2.1 containing 1 µg of supercoiled PhiX174 DNA and a minimum of 10 Units of BstYI incubated for 4 hours at 60°C results in <50% conversion to the nicked form as determined by agarose gel electrophoresis.	Pass

Protein Purity Assay (SDS-PAGE) - BstYI is >95% pure as determined by SDS PAGE analysis using Coomassie Blue detection.	Pass
