<b>Exonuclease Activity (Radioactivity Release)</b> A 50 µl reaction in NEBuffer 3.1 containing 1 µg of a mixture of single and double-stranded [ <sup>3</sup> H] E. coli DNA and a minimum of 100 units of Pcil incubated for 4 hours at 37°C releases <0.1% of the total radioactivity.	Pass
<b>Endonuclease Activity (Nicking)</b> A 50 µl reaction in NEBuffer 3.1 containing 1 µg of supercoiled PhiX174 DNA and a minimum of 10 Units of Pcil incubated for 4 hours at 37°C results in <10% conversion	Pass
