A fragmentation time of 20 minutes was used to generate an insert size of approximately 200 bp. The final average library size is between 270 and 450 bp as determined by an Agilent Bioanalyzer. Libraries made from the previous and current lots for both input DNA amounts are sequenced together on the same Illumina flow cell and compared across various metrics including library yield, fraction of reads aligning to the reference, GC bias, and insert size.
