an insert size of approximately 100 bp. The final average library size is between	
200 bp and 600 bp as determined by an Agilent Bioanalyzer® or TapeStation®.	
Libraries are sequenced together on an Illumina® flow cell and assessed across	
various metrics including library yield, mapping rate to the SARS-CoV-2 genome and	
amplicon coverage. For 0.5 million paired end reads, all expected amplicons are	
covered by at least 100 overlapping reads.
