Endonuclease Activity (Nicking) - A 50 µl reaction in NEBuffer 3.1 containing 1 µg of supercoiled pNEB193 DNA and a minimum of 50 units of PflMI incubated for 4 hours at 37°C results in <10% conversion to the nicked form as determined by agarose gel electrophoresis.	Pass
Exonuclease Activity (Radioactivity Release) - A 50 µl reaction in NEBuffer 3.1 containing 1 µg of a mixture of single and double-stranded [³ H] <i>E. coli</i> DNA and a minimum of 100 units of PflMI incubated for 4 hours at 37°C releases <0.1% of the total radioactivity.	Pass
